

# Maryland Film Production Activity Tax Credit Annual Report

Pursuant to Tax General Article §10-730

#### **Maryland Film Production Activity Tax Credit**

#### Overview

In 2018, Senate Bill 1154 – Income Tax – Film Production Activity Tax Credit – Alterations was enacted and made the following changes to the Maryland Film Production Activity Tax Credit:

- 1) The minimum spend for most film projects was lowered to \$250,000;
- 2) The maximum amount of tax credits available for a film project is \$10,000,000;
- 3) The salary, wages, and other compensation paid to Writers, Directors and Producers are not included in total direct costs;
- 4) A new category of films was created for Maryland small or independent film entities (Maryland Small Films) with total direct costs greater than \$25,000;
- 5) Ten percent of the annual authorized credit amount is set aside for Maryland Small Films; and,
- 6) The statute authorized \$8,000,000 in credits for FY 2019, \$11,000,000 in credits for FY 2020, \$14,000,000 in credits for FY 2021, \$17,000,000 in credits for FY2022, and \$20,000,000 in credits for FY2023 and each fiscal year thereafter.

The 2020 BRFA fixed the annual authorized credit amount for the program at \$12 million for FY 2021 and beyond.

Tax General Article §10-730 requires Commerce to report on specific data before January 1 of each year:

- 1) the number of film production entities submitting applications;
- 2) the number and amount of tax credit certificates issued;
- 3) the number of local technicians, actors, and extras hired for film production activity during the reporting period;
- 4) a list of companies doing business in the State, including hotels, that directly provided goods or services for film production activity during the reporting period;
- 5) a list of companies doing business in the State that directly provided goods or services for film production activity during the reporting period that qualified during the reporting period as minority enterprise under §14-301(F) of the State finance and Procurement article;

- 6) a list of companies doing business in the State that directly provided goods or services for film production during the reporting period that, as determined by the Department, are considered small businesses; and
- 7) any other information that indicates the economic benefits to the State resulting from film production activity during the reporting period.

#### **Specifics**

### Two applications for qualification for FY 2022 tax credits were submitted and approved in FY 2022.

With production still recovering from the COVID-19 pandemic, the Maryland Film Office (MFO) did not begin accepting applications for qualification for FY 2022 tax credits until Friday, October 15, 2021.

Clown Show LLC applied for tax credits for its 8-episode series, *The Clowns*, on October 18, 2021. Based on the company's application, a 27% credit of the estimated total of authorized direct costs in Maryland would qualify Clown Show LLC for a maximum of \$216,000 in tax credits.

Eye on the Ball Enterprises Inc. applied for tax credits for its series, *Lady in the Lake*, on December 3, 2021. Based on the company's application, a 27% credit of the estimated total of authorized direct costs in Maryland would qualify Eye on the Ball Enterprises Inc. for a maximum of \$10,000,000 in tax credits as limited by statute.

Additionally, on July 1, 2021, \$153,128 in FY 2022 tax credits were reserved for Safe Space Movie LLC which applied for tax credits for its television film, *Safe Space*, on April 7, 2021. Based on the company's application, a 25% credit of the estimated total of authorized direct costs in Maryland would qualify Safe Space Movie LLC for a maximum of \$300,000 in tax credits. \$146,872 of the \$300,000 in tax credits were reserved for Safe Space Movie LLC in FY 2021 on May 10, 2021.

The final tax credit amount for each production, however, will be based on the companies' actual qualified direct spend determined upon conclusion of the production activity in the State and after the application for final tax credit certification and all closing documentation, including a Report on Agreed Upon Procedures from an independent, third-party CPA, have been submitted and reviewed. The MFO anticipates the final amount of tax credits issued to these productions to remain at the maximum amount reserved.

### One application for qualification for FY 2023 tax credits was submitted and approved in FY 2022.

By the end of the first quarter of 2022, it was clear production was returning to somewhat normal. Accordingly, the Maryland Film Office began accepting applications for qualification for FY 2023 tax credits at 9:00 a.m. on Monday, March 21, 2022.

King Street Productions Inc. applied for tax credits for its series, *Lioness*, at on March 21, 2022. Based on the company's application, a 27% credit of the estimated total of authorized direct costs in Maryland would qualify King Street Productions Inc. for a maximum of \$10,000,000 in tax credits as limited by statute.

### Five applications for qualification for FY 2022 tax credits for Maryland Small Films were submitted and approved in FY 2022.

Ms. Nishi Chawla of Clinton submitted applied as an individual for her film, *Techno*, on July 19, 2021. Based on the company's application, a 25% credit of the estimated total of authorized direct costs in Maryland would qualify Ms. Chawla for a maximum of \$11,014 in tax credits.

Misfits Productions LLC of Clinton submitted an application for its short film, *PG-13*, on September 1, 2021. Based on the company's application, a 25% credit of the estimated total of authorized direct costs in Maryland would qualify Misfits Productions LLC for a maximum of \$7,500 in tax credits.

Three Roads Communications Inc. of Frederick submitted an application for its documentary, *The House on Jonathan Street*, on February 8, 2022. Based on the company's application, a 25% credit of the estimated total of authorized direct costs in Maryland would qualify Three Roads Communications Inc. for a maximum of \$50,500 in tax credits.

Rich is Relative Media LLC dba SideXSide Studios of Takoma Park submitted an application for its corporate film series, *E4USA 2022 Instruction Video Series*, on February 25, 2022. Based on the company's application, a 25% credit of the estimated total of authorized direct costs in Maryland would qualify Rich is Relative Media LLC dba SideXSide Studios for a maximum of \$18,015 in tax credits.

DBM Communications Inc. of Towson submitted an application for its film, *Little Hero*, on June 1, 2022. Based on the company's application, a 25% credit of the estimated total of authorized direct costs in Maryland would qualify DBM Communications Inc. for a maximum of \$24,177 in tax credits.

The final tax credit amount for each production, however, will be based on the companies' actual qualified direct spend determined upon conclusion of the production activity in the State and after the application for final tax credit certification and all closing documentation have been submitted and reviewed.

Attached is a summary outlining tax credits in progress or closed through FY 2022. (*Appendix A - Maryland Film Production Activity Tax Credit Recipients FY 2012-FY 2022*)

#### Three companies were issued a Final Tax Credit certificate during FY 2022.

Rich is Relative Media LLC dba SideXSide Studios was issued a final tax credit certificate on February 15, 2022, for its corporate film series, *E4USA Instruction Video Series 2021*, which completed 4 days of filming on June 18, 2021. They submitted their application for final tax credit

certification, along with their closing documentation, on January 10, 2022. The materials were reviewed by MFO staff and the final tax credit certificate was issued on February 15, 2022. *E4USA Instruction Video Series 2021* received a tax credit of \$14,004 and had an economic impact of \$95,229. The production hired 6 local technicians, no actors or extras and provided business for 4 local Maryland companies. Attached is a copy of the vendor list for *E4USA Instruction Video Series 2021*. Sonset Friday Entertainment LLC was issued a final tax credit certificate on April 18, 2022, for its film, *Hope Lives*, which completed 13 days of filming on June 22, 2021. They submitted their application for final tax credit certification, along with their closing documentation, on January 21, 2022. The materials were reviewed by MFO staff and the final tax credit certificate was issued on April 18, 2022. *Hope Lives* received a tax credit of \$13,442 and had an economic impact of \$115,761. The production hired 10 local technicians, 14 local actors and extras and provided business for 17 local Maryland companies. Attached is a copy of the vendor list for *Hope Lives*. (*Appendix C – Hope Lives Vendor List*)

TRTG Productions LLC was issued a final tax credit certificate on June 27, 2022, for its film, *The Road to Galena*, which completed 32 days of filming on May 14, 2021. They submitted their application for final tax credit certification, along with their closing documentation, on February 16, 2022. The materials were reviewed by MFO staff and the final tax credit certificate was issued on June 27, 2022. *The Road to Galena* received a tax credit of \$125,000.00 and had an economic impact of \$1,164,237. The production hired 35 local technicians, 3 local actors and extras and provided business for 270 local Maryland companies, vendors and contractors. #### **Background**

CH 516 Acts of 2011 created the Film Production Activity Tax Credit (Film Tax Credit). The Act repealed the then existing Film Production Rebate Program and replaced it with a tax credit for qualified direct costs of qualified film production activities including feature films and television series. Under the Film Tax Credit, the Department of Commerce (Commerce), formerly the Department of Business and Economic Development (DBED), could award a maximum of \$7.5 million in credits in each fiscal year beginning in FY 2012 through FY 2014. Qualifying production activities were eligible for a tax credit of up to 25% of the qualified direct costs for a feature film and 27% for a television series. If the amount of the tax credit exceeded the total tax liability in the tax year, the entity could claim a refund in the amount of the excess. The Act became effective on July 1, 2011 with a sunset date of June 30, 2014.

A total of \$22.5M (\$7.5 per FY) in tax credits was available for FYs 2012 through 2014. All of those tax credits were committed by January 2012 to six productions: *House of Cards - Season 1*; *VEEP - Seasons 1 & 2; Jamesy Boy; Better Living through Chemistry*; and, *Ping Pong Summer*.

In order to retain the filming of the two television series *House of Cards* and *VEEP* in Maryland, CH 28 Acts of 2013 authorized \$32.5 million in additional film tax credits over three years and extended the sunset through FY 2016. All of the tax credits were committed by the end of the first day Commerce began accepting applications (April 17, 2013). Those credits were committed to *House of Cards – Season 2* and *VEEP – Seasons 3 & 4*.

During the 2014 legislative session, House Bill 520 Business and Economic Development – Film Production Activity Tax Credit Program was introduced to increase the amount of tax credits the Secretary could issue in FY 2015 from \$7.5 million to \$11 million. Senate Bill 1051 Business and Economic Development – Film Production Activity Tax Credit Program was also introduced and proposed an increase from \$7.5 million to \$18.5 million. Both bills passed with amendments but failed to pass before the end of the legislative session. SB172 - the Budget Reconciliation and Financing Act - authorized funds from the Economic Development Opportunities Fund (Sunny Day) and Special Fund for Preservation of Cultural Arts to provide a \$7.5 million grant to enhance the Film Tax Credit, thus providing \$11.5 million in incentives for *House of Cards – Season 3*.

Senate Bill 905, Income Tax – Film Production Activity Tax Credit, introduced in the 2015 legislative session, was originally proposed to increase the amount of tax credits available for production activity in a fiscal year and extend the program's sunset date (\$25 million per fiscal year through FY 2019). However, during the last week of the session, the bill was amended to create the Film Production Tax Credit Reserve Fund with no funding attached. The new structure of the program required the Department to report the amount of tax credits necessary to maintain the current level of film production activity and to attract new production activity to the Governor. This amount would then be considered for inclusion in the Governor's FY budget and acted upon by the General Assembly during the legislative session. In addition, some new reporting and promotional requirements were mandated. The legislation went into effect on July 1, 2015.

As previously stated, in 2018, the legislature passed Senate Bill 1154 which (1) repealed the Reserve Fund, (2) eliminated the sunset on the program, (3) authorized specific tax credit funding for each fiscal year through FY 23 and beyond, (4) capped the maximum amount per project at \$10 million, and (4) created a new category of films, Maryland small and/or independent productions (Maryland Small Films), eligible for the tax credit. The legislation also mandated that 10% of the annual authorized credit amount must be set aside for Maryland Small Films.

In 2019, the statutory requirement that in order to qualify as a Maryland Small Film an entity must be organized in Maryland for at least one year was altered to at least three months. And, in 2020, the BRFA fixed the annual authorized credit amount for the program at \$12 million for FY 2021 and beyond.
